The Club will be open Friday, July 4th, noon to 8:00 PM with last call at 7:30 PM. Have a fun and safe Independence Day.

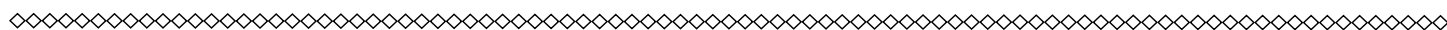

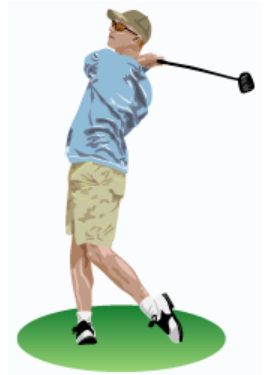

PROPOSED CONSTITUTION AND BY-LAWS CHANGES

April 8, 2014

These proposals are submitted by the Executive Committee of the Casino Club.

ARTICLE II

Section 2B Currently reads: "Election of candidate shall be by secret ballot and a simple majority of of votes cast shall elect or reject. Black and white balls may be used rather than a printed ballot with the white ball indicating a favorable vote and the black ball an unfavorable vote."

Section 2B Proposed: Election of candidate shall be in a manner set forth by the meeting Chairperson.

This allows for a "show of hands" vote as an alternative method of voting and of course using the marbles or ballots is still an option also.

ARTICLE II

Section 2D Currently reads: "New members shall be considered to be on probation for the first two (2) years of membership. During this period, such members shall be required to work a minimum of two (2) functions, (eg. Parties, work details, etc.) of their choice. They must also attend at least one (1) General Membership Meeting per year during this probationary period. If these requirements are not fulfilled by the end of the probationary period, their membership will be automatically terminated."

Section 2D Proposed: New members shall be considered to be on probation for the first (1) year of membership. This probationary period shall begin the first month after attending their initiation meeting. During this period the probationary member is required to attend a minimum of two (2) General Membership Meetings and perform work at two (2) club functions. If these requirements are not fulfilled by the end of the probationary period, their membership will be automatically terminated.

This cuts probation down to one year, but still requires meetings and functions to be performed. It also eliminates the confusion caused by the 2 functions any time, but 1 meeting a year.

ARTICLE V

Section 3 Currently reads: "All dues must be paid between December 1st and the last business day of February. Dues must be paid with a check or money order. Persons receiving the dues for the Casino Club of Grand Rapids must date and initial the back of the membership card upon receiving dues. If any member fails to pay his annual dues before March 1st, he will be dropped from the membership rolls of the Society. He can only be reinstated under the regular procedure as prescribed for new members."

Section 3 Proposed: Revise the sentence "Dues must be paid with a check or money order." To read: "Dues may be paid in a manner acceptable to the Executive Committee."

This paves the way for credit cards and/or cash as a method of payment now or in the future.

ARTICLE VII

Section I Currently reads: "The Executive Committee shall be responsible for, and have jurisdiction over the bonding procedure."

Section I Proposal: Delete the article and renumber the rest accordingly.

Currently bonding is an out dated procedure and we haven't done it in years, we are insured instead.

End of proposals.
