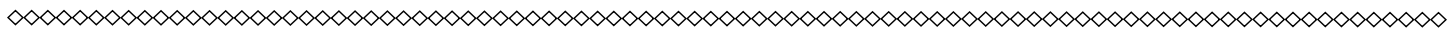
The club will be open Memorial Day, Monday, May 30th from noon until 8:00 p.m. Last call will be at 7:30 p.m.

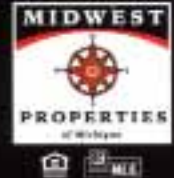
